



**Trade Secret Statement:** The concentration of water and barium sulfate as well as the identifier and concentration of each additional component have been withheld under a trade secret. These components are either nonhazardous or are present at sufficiently low concentrations such that they do not significantly affect the hazard classification of this product.

### 4. FIRST AID MEASURES

#### First Aid Procedures:

**Inhalation:** Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. Get medical attention if symptoms occur.

**Ingestion:** Do not induce vomiting unless directed to do so by medical personnel. If vomiting occurs, keep head low so that vomit does not enter lungs. Rinse mouth. Never give anything by mouth to an unconscious person. Call a physician or poison control center.

**Skin Contact:** Wash skin with plenty of water for at least 15 minutes. Remove contaminated clothing and shoes. Wash clothing before reuse. Get medical attention if symptoms occur.

**Eye Contact:** Check for and remove contact lenses. Immediately flush eyes with gentle but large stream of water for at least 15 minutes, lifting lower and upper eyelids occasionally. Get medical attention immediately.

Precautions for Firefighters:**

As in any fire, wear MSHA/NIOSH-approved (or equivalent), self-contained, positive-pressure or pressure-demand breathing apparatus and full protective gear. Use water spray to cool unopened containers. Move containers from fire area if you can do so without risk. In the event of fire and/or explosion, do not breathe fumes.

## 6. ACCIDENTAL RELEASE MEASURES

Isolate hazard area and keep unnecessary and unprotected personnel away from the area of the leak or spill. Wear appropriate personal protective equipment (see Section 8). Avoid contact with eyes, skin, and clothing.

**Methods for Containment:**

Absorb spill with an inert material (e.g. vermiculite, dry sand, earth, cloth, or fleece) and place in a non-combustible container for reclamation or disposal. Do not flush to sewer. Clean contaminated surface thoroughly. Never return spills in original containers for reuse. Clean up in accordance with all applicable regulations.

## 7. HANDLING AND STORAGE

**Handling:**
