2. PHYSICAL DATA:

Product is a liniment that consists of oil-based products used to treat equine leg conditions.

3. FIRE AND EXPLOSION DATA:

Product will ignite only in the presence of other combustibles at high temperatures. Although product is non-flammable, in fire situations it may present a health hazard to fire fighters.

EXTINGUISHING MEDIA: Use Carbon dioxide, dry chemical or spray foam extinguisher.

4. REACTIVITY DATA:

The product is expected to be stable under normal storage conditions.

5: ENVIRONMENTAL AND DISPOSAL INFORMATION:

ACTION TO TAKE FOR SPILLS/LEAKS: Contain spill and absorb using a suitable absorbent material (vermiculite, etc), sweep up and dispose of in DOT approved waste containers. Keep out of sewers, storm drains, surface waters and soil.

DISPOSAL METHOD: Dispose of contaminated product and materials used in cleaning up spills or leaks in a manner approved for this material. Consult appropriate federal, state and local regulatory agencies to ascertain proper disposal procedures.

6. HEALTH HAZARD DATA:

EYE: Avoid eye contact. Due to blistering characteristics, product could cause blindness.

SKIN CONTACT: Product is a blistering agent and will produce a burning sensation and blistering of skin. Immediately wash effected areas with soap and water. Avoid contact with cuts or open wounds.

INGESTION: The effects of accidental ingestion of this product may cause a blistering of the gastrointestinal tract and circulatory disturbances.

INHALATION: Persons with breathing problems should avoid direct inhalation.
