Our products, Proanthozone<sup>®</sup>, Prosamine<sup>®</sup>, ProAnimal<sup>®</sup>, ProQuiet<sup>®</sup>, ProNeurozone<sup>®</sup>, ProMotion<sup>®</sup> (distributed by Virbac), and Pro-EQ<sup>®</sup> do not require a Material Safety Data Sheet (MSDS) based upon the following reference provided by James Schafer, D.V.M. of Schafer Veterinary Consultants.

OSHA Hazard Communications Standard 29 CFR, §1910.1200 (b) (5) (iii) indicates that "any food, food additive, color additive, drug, cosmetic, or medical or veterinary device or product" does not require a material safety data sheet. This would include Animal Health Options' products.

As nutritional supplements, Proanthozone<sup>®</sup>, ProMotion<sup>®</sup>, Prosamine<sup>®</sup>, ProAnimal<sup>®</sup>, ProQuiet<sup>®</sup>, ProNeurozone<sup>®</sup>, ProMotion<sup>®</sup>, and Pro-EQ<sup>®</sup> are exempt from the requirement that an MSDS be provided. Animal Health Options has received reports of several companion animals ingesting an entire bottle of Proanthozone<sup>®</sup> without noticeable side effects. When large quantities of ProQuiet<sup>®</sup> have been ingested, the only noticeable side effects were lethargy and a moderate degree of sedation. As a precautionary note, our veterinary advisor suggests that if an animal does ingest large quantities of any of our products, the following safety measures be taken:

- Induce vomiting by oral administration of one part hydrogen peroxide mixed with one part water.
- Prevent further absorption with oral administration of activated charcoal.

Though there are few known contraindications, the widespread use and knowledge of antioxidants and other supplements today warrants <u>caution</u> when using these products in conjunction with other drugs (i.e. anti-cancer products). In particular, combining ProQuiet<sup>®</sup> with tricyclic anti-depressants such as clomipramine or selective serotonin reuptake inhibitors (SSRI's) is <u>NOT</u> recommended as it could lead to adverse effects.
