## **Manufacturer Safety Data Sheet**

## **Ingredients**

Aconite Napellus 10x & 200c

(Monkshood)

Signs are worse at night, so a night storm is even more

frightening. Fear from sudden noises or storms.

Avena Sativa 7x & 2c

(Common Oat)

Anti-neurotic for calming the nervous system and is useful for

palpatations and nervous exhaustion.

Belladonna 30c

(Deadly Nightshade)

Useful for normally quiet individuals. Very sensitive to the flash of lightning causing terror with dilated pupils, even aggression.

Borax 6c & 30c

(Borate of Sodium)

Fear of gunshots, any sudden noise or loud noise. Drooling is often a symptom. Super alert animals, like rabbits, with

trembling whiskers as it sniffs the air for predators.

Calcarea Phosphorica 30c & 200c

(Calcium Phosphate)

Fear of thunder, and will shake, tremble and bolt during a storm.

Gelsemium 6c, 30c & 200c

(Yellow Jasmine)

Used for anticipatory anxiety with trembling and the animal becomes paralyzed with fear. Diarrhea or involuntary urination

may occur when under extreme stress.

Lycopodium 6c & 30c

(Club Moss)

Fear of wind and sound storms. Anticipatory anxiety.

Natrum Carbonicum 30c & 200c

(Carbonate of Soda)

A sensititivity to any electrical changes. Start reacting before the storm starts. Alert and sensitive individual as in Borax.

**Natrum Muriaticum 30c** 

(Sodium Chloride)

Sound sensitivity. Often averse to company, not making eye contact. Can be sad looking. Prone to self-mutilate, causing a

lick granuloma.

Passaflora 7x & 2c

(Passion Flower)

Calming, anti-convulsant. Quiets the entire nervous system.

Anxiolytic like Avena, Valeriana & Skullcap.

Phosphorus 6c, 30c, 200c & 1M

(Mineral Phosphorus)

Super-sensitive to all external impressions, particularly thunder and lightning storms, with a fear of the dark. Friendly, yet vet-

phobic, anticipating any intervention.

Rhododendron 6c

(Rhododendron Chrysanthum)

Very much affected by windy, or wet stormy weather. Helpful for stiffness from arthritis that is aggravated by the storm.

Scutellaria Lateriflora 7x & 2c

(Blue Skullcap)

Restlessness or unease from nervous fear or excitement.

Silica Terra 30c & 200c

(Pure Flint)

Strongly affected by changes of weather, noise and light as in storms, hurricanes, tornados, thunder, lightning and fireworks.

Stramonium 30c

(Jimson Weed)

Terror with wide-eyed look, that can lead to aggression. Has a

strong fear of the dark, re-homing or abandonment.

Staphysagria 6c & 30c

(Stavesacre)

Animal is afraid of its own shadow. Supersensitive to every impression, including touch and noise. Can alleviate resultant physical symptoms such as skin eruptions that are sensitive to the touch.

Valeriana 7x & 2c

(Valerian Root)

Hysteria with over-sensitivity, more so when alone in the dark.

**INDICATIONS:** Anxiety or anxiety induced conditions: fear of thunder, fireworks, wind and loud noises, gunshots, hurricanes, tornados, and kennel phobias where noise phobia is the causative factor.

**FORMS:** Liquid **PACKAGE SIZE:** 15 ml bottle

**DOSE:** One dose (10 drops) every 15 minutes up to 4 doses if needed. In acute cases, the doses can be given every 5 minutes up to 6 doses until response is seen. Individuals less than 2lbs dilute 1drop in ¼ oz water then give 1-5 drops of medicated water dependant on size of individual or mist in the air for treatment by olfaction (inhalation), especially useful in frightened individuals difficult to medicate or those sensitive to the alcohol preservative.

**PREVENTION WHILE OWNER IS AWAY:** 15 drops of product may be put in water bowl for each dog who is home alone during storm season or similar events. Discontinue treatment as condition improves.

**ADMINISTRATION:** Optimally, the liquid preparation should be dropped directly on to the mucous membrane of the mouth including lips; ideally in dogs by pulling out the labial pouch. Where an animal finds this distressful or an owner is unable to comply, the medication can be put in the food, water or milk, or added to a sprayer and misted into the air or put onto bedding. Where animals are sensitive to the odor of the alcohol preservative, a 10-20 minute period should be allowed for dilution and evaporation before the liquid or food is presented to the patient. Occasionally, animals will shake their heads as a response to the alcohol preservative; in these cases presenting it in food, water, milk or aerosol works.

**ADVERSE EFFECTS AND CONTRAINDICATIONS:** None known, other than reversible effect of overdose. Overdose will result in a return of symptoms after the symptoms have initially reduced. Where a return of symptoms occurs due to overdose of the medication, ceasing the medication will alleviate the effect. Patients who are hypersensitive to homeopathic preparations will show response to a single dose, which may not need to be repeated for some time as this can present as sudden deep sleep from relaxation. For this reason therapy should always start with a single dose the previous day and should a major response be seen, therapy should not be recommenced until symptoms relapse, and then only a single dose given for maximum effect. Although there no evidence that there are any safety issues, extra care should be always be taken when dealing with pregnant animals. Should a suspected adverse reaction be seen or advice needed, please contact HomeoPet, LLC (contact information at bottom of sheet).

DRUG INTERACTIONS: None known. For animal use only. Keep out of reach of children.

**PHARMACEUTICAL PRECAUTIONS:** Store at room temperature, out of direct sunlight, and away from strong odors.

**USER SAFETY:** No adverse effects have been recorded. There have been reports to the company of beneficial rather than adverse effects. As homeopathics are active in humans, care is advised when handling product, although a long history of homeopathics used in humans shows a very high safety margin.

**ENVIRONMENTAL IMPACT:** To date none found.
