EMERGENCY OVERVIEW: Product Description: This product is a white, odorless cream. **Health Hazards:** The chief health hazard associated with exposure during normal use and handling is the potential for irritation of contaminated skin. Individuals who have had allergic reactions to products containing the active ingredient, Clobetasol Propionate, other corticosteroids, or any other components of this product may experience allergic reactions to this product. Repeated skin exposure of Clobetasol Propionate may cause adverse reproductive effects, based on animal data. **Flammability Hazards:** If heated to high temperatures for a prolonged period, the water in this product can evaporate off and the residue may ignite. When involved in a fire, this material may decompose and produce irritating vapors and toxic compounds (including carbon oxides, hydrogen chloride, and hydrogen fluoride). **Reactivity Hazards:** This product is not reactive. **Environmental Hazards:** This product has not been tested for environmental effects. **Emergency Considerations:** Emergency responders should wear appropriate protection for situation to which they respond.



Symptoms of chronic overexposure by this route may include reversible hypothalamic-pituitaryadrenal (HPA) axis suppression, abnormal accumulations of facial and trunk fat, fatigue, high blood pressure, osteoporosis, abnormally high level of glucose in the blood, and abnormally high levels of glucose in the urine.

INGESTION: Ingestion is not a significant route of occupational overexposure. Acute ingestion of large quantities of this product or chronic ingestion caused by poor hygiene practices may cause adverse symptoms. Symptoms of ingestion overexposure may include nausea, vomiting, and diarrhea.

SENSITIZATION OF PRODUCT: Corticosteroids (such as Clobetasol Propionate) may cause allergic contact dermatitis. Rarely, the Cetostearyl Alcohol component of this product can cause allergic skin reaction with hives.

HEALTH EFFECTS OR RISKS FROM EXPOSURE: An Explanation in Lay Terms. Overexposure to this product may cause the following health effects:

Mutagenicity/Embryotoxicity: Animal studies have not been performed to evaluate the mutagenicity/embryotoxicity or reproductive toxicity of Clobetasol Propionate. No human data are available.

Teratogenicity: Corticosteroids have been shown to be teratogenic in laboratory animals when administered systemically at relatively low dosage levels. Some corticosteroids have been shown to be teratogenic after dermal application in laboratory animals. Clobetasol Propionate is absorbed percutaneously and when administered subcutaneously, it was a significant teratogen in both the rabbit and the mouse. Clobetasol Propionate has greater teratogenic potential than steroids that are less

ACGIH BIOLOGICAL EXPOSURE INDICES (BEIS): Currently, there are no ACGIH Biological Exposure Indices (BEIS) determined for components of this product.

12. ECOLOGICAL INFORMATION

ALL WORK PRACTICES MUST BE AIMED AT ELIMINATING ENVIRONMENTAL CONTAMINATION.

MOBILITY: This product has not been tested for soil absorption or mobility. The following information is available for the components of this product:

PROPYLENE GLYCOL:

The Koc of Propylene Glycol is estimated as 8, using a log Kow of -0.92 and a regression-derived equation. According to a classification scheme, this estimated Koc value suggests that Propylene Glycol is expected to have very high mobility in soil.

PERSISTENCE AND BIODEGRADABILITY: This product has not been tested for persistence or biodegradability. The following information is available for the components of this product: PROPYLENE GLYCOL:

Based on a classification scheme, an estimated Koc value of 8, determined from a log Kow of -0.92 and a regression-derived equation, indicates that Propylene Glycol is expected to have very high mobility in soil. Volatilization of Propylene Glycol from moist soil surfaces is not expected to be an important fate process given an estimated Henry's Law constant of 1.3X10-8 atm-cu m/mole, derived from its vapor pressure, 0.13 mmHg, and water solubility, 1X10+6 mg/liter. Propylene Glycol is not expected to volatilize from dry soil surfaces based upon its vapor pressure. Laboratory experiments using agricultural soils from South Carolina conducted at 22 deg C and a fortification of 1,000 ppm Propylene Glycol, yielded 73-78% mineralization during a 51 day incubation period, suggesting that biodegradation will be an important fate process in soils. Based on a classification scheme, an estimated Koc value of 8, determined from a log Kow of -0.92 and a regression-derived equation, indicates that Propylene Glycol is not expected to adsorb to suspended solids and sediment. Volatilization from water surfaces is not expected based upon an estimated Henry's Law constant of 1.3X10-8 atm-cu m/mole, derived from its vapor pressure, 0.13 mmHg, and water solubility, 1X10+6 mg/L. Numerous screening studies using wastewater or sewage inoculum as seed, suggests that Propylene Glycol will be degraded readily under aqueous environments. According to a model of gas/particle partitioning of semi-volatile organic compounds in the atmosphere, Propylene Glycol, which has a vapor pressure of 0.13 mmHg at 25°C, is expected to exist solely as a vapor in the ambient atmosphere. Vapor-phase Propylene Glycol is degraded in the atmosphere by reaction with photochemically-produced hydroxyl radicals; the half-life for this reaction in air is estimated to be 32 hours, calculated from its rate constant of 1.2X10-11 cu cm/molecule-sec at 25°C

BIOACCUMULATION: This product has not been tested for bioconcentration. The following information is available for the components of this product:

SYMPTOMS OF EXPOSURE BY ROUTE OF EXPOSURE: The health hazard information provided below is pertinent to medical employees handling this product in an occupational setting. The following paragraphs describe the symptoms of exposure by route of exposure.

Inhalation: Inhalation is unlikely due to viscosity. If aerosols are somehow generated and inhaled, irritation of the nose and upper respiratory system may occur. Symptoms of such exposure may include sneezing, coughing, and nasal congestion. In persons susceptible to corticosteroids, inhalation can cause bronchospasm, with an immediate increase in wheezing. Glaucoma, increased intraocular pressure, and cataracts have been reported following the long-term administration of inhaled corticosteroids.

Contact with Skin or Eyes: Prolonged skin contact may cause dermatitis (dry, red, cracked skin), thinning of skin and suppression of adrenal cortex (decreased ability to respond to stress) and increased susceptibility to bacterial and fungal infections. Contact of this product with the eyes may cause moderate to severe irritation, redness, and tearing.

Skin Absorption: This product is designed to be absorbed into the skin. REPRODUCTIVE TOXICITY INFORMATION: There are no adequate and well-controlled studies of this product in pregnant women; however, this product may cause fetal harm when administered to a pregnant woman. In the workplace, the risk to the fetus should be communicated and the appropriate action should be taken to prevent exposure in accordance with company policy and regulatory requirements. This product is rated by the FDA for therapeutic risk as Pregnancy Risk Category C (Animal reproduction studies have shown an adverse effect on the fetus and there are no adequate and well-controlled studies in humans, but potential benefits may warrant use of the drug in pregnant women despite potential risks).

Mutagenicity: Clobetasol Propionate was negative in the in vitro mammalian chromosomal aberration test and in the in vivo mammalian erythrocyte micronucleus test.

Embryotoxicity/Teratogenicity:

Human Data: As a group, corticosteroids have not been associated with congenital malformations in humans.

Animal Data: Corticosteroids have been shown to be teratogenic in laboratory animals when administered systemically at relatively low dosage levels. Some corticosteroids have been shown to be teratogenic after dermal application to laboratory animals. Clobetasol Propionate is absorbed percutaneously, and when administered subcutaneously it was a significant teratogen in both the rabbit and the mouse. Clobetasol propionate has greater teratogenic potential than steroids that are less potent. The effect of Clobetasol Propionate on pregnancy outcome and development of offspring was studied in the rat. Clobetasol propionate was administered subcutaneously to female rats twice daily (0, 12.5, 25, and 50 µg/kg/day) from day 7 of presumed gestation through day 25 of lactation or day 24 presumed gestation for those rats that did not deliver a litter. The maternal NOEL for Clobetasol Propionate was less than 12.5 μg/kg/day due to reduced body weight gain and feed consumption during the gestation period. The reproductive NOEL in the dams was 25 µg/kg/day (ratio of animal dose to proposed human dose of 0.07 on a mg/m²/day basis) based on prolonged delivery at a higher dose level. The no-observedadverse-effect-level (NOAEL) for viability and growth in the offspring was 12.5 µg/kg/day (ratio of animal dose to proposed human dose of 0.03 on a mg/m²/day basis) based on incidence of stillbirths, reductions in pup body weights on days 1 and 7 of lactation, increased pup mortality, increases in the incidence of umbilical hernia, and increases in the incidence of pups with cysts on the kidney at higher dose levels during the pre-weaning period. The weights of the epididymides and testes were significantly reduced at higher dosages. Despite these changes, there were no effects on the mating and fertility of the

Reproductive Toxicity: The effect of subcutaneously administered Clobetasol Propionate on fertility and general reproductive toxicity was studied in rats at doses of 0, 12.5, 25, and 50 µg/kg/day. Males were treated beginning 70 days before mating and females beginning 15 days before mating through day 7 of gestation. A dosage level of less than 12.5 µg/kg/day Clobetasol Propionate was considered to be the no-observed-effect-level (NOEL) for paternal and maternal general toxicity based on decreased weight gain and for male reproductive toxicity based on increased weights of the seminal vesicles with fluid. The female reproductive NOEL was 12.5 µg/kg/day (ratio of animal dose to proposed human dose of 0.03 on a mg/m2/day basis) based on reduction in the numbers of estrous cycles during the pre-cohabitation period and an increase in the number of nonviable embryos at higher doses.

It is not known whether topical administration of corticosteroids could result in sufficient systemic absorption to produce detectable quantities in breast milk.

Non-Teratogenic Effects: Hypoadrenalism may occur in infants born of mothers receiving corticosteroids during pregnancy.

MOBILITY: This product has not been tested for soil absorption or mobility. The following information is available for the components of this product:

CETOSTEARYL ALCOHOL: The Koc is estimated as 25,000, using a water solubility of 4.122X10-2 and a regression-derived equation. According to a classification scheme, this estimated Koc value suggests that this material is expected to be immobile in soil.

PROPYLENE GLYCOL: The Koc is estimated as 8, using a log Kow of -0.92 and a regression-derived equation. According to a classification scheme, this estimated Koc value suggests that this compound is expected to have very high mobility in soil.

PERSISTENCE AND BIODEGRADABILITY: This product has not been tested for persistence or biodegradability. The following information is available for the components of this product:

CETOSTEARYL ALCOHOL: If released to air, a vapor pressure of 6X10-6 mm Hg at 25°C indicates this material will exist in both the vapor and particulate phases in the atmosphere. Vapor-phase material will be degraded in the atmosphere by reaction with photochemically-produced hydroxyl radicals; the half-life for this reaction in air is estimated to be 16 hours. Particulate-phase material will be removed from the atmosphere by wet or dry deposition. If released to soil, this compound is expected to have no mobility based upon an estimated Koc of 25,000. Volatilization from moist soil surfaces is expected to be an important fate process based upon an estimated Henry's Law constant of 4.6X10-2 atm-cu m/mole. However, adsorption to soil is expected to attenuate volatilization. Various biological screening studies have demonstrated that this compound biodegrades both aerobically and anaerobically. If released into water, this material is expected to adsorb to suspended solids and sediment based upon the Volatilization from water surfaces is expected to be an important fate process based upon this compound's estimated Henry's Law constant. Estimated volatilization half-lives for a model river and model lake are 23 hours and 12 days, respectively. However, volatilization from water surfaces is expected to be attenuated by adsorption to suspended solids and sediment in the water column. The estimated volatilization half-life from a model pond is 1.8 years if adsorption is considered. Hydrolysis is not expected to be an important environmental fate process since this compound lacks functional groups that hydrolyze under environmental conditions.

PROPYLENE GLYCOL: Based on a classification scheme, an estimated Koc value of 8, determined from a log Kow of -0.92 and a regression-derived equation, indicates that this material is expected to have very high mobility in soil. Volatilization of this compound from moist soil surfaces is not expected to be an important fate process given an estimated Henry's Law constant of 1.3X10-8 atm-cu m/mole, derived from its vapor pressure, 0.13 mmHg, and water solubility, 1X10+6 mg/liter. This compound is not expected to volatilize from dry soil surfaces based upon its vapor pressure. Laboratory experiments using agricultural soils from South Carolina conducted at 22°C and a fortification of 1,000 ppm this compound, yielded 73-78% mineralization during a 51 day incubation period, suggesting that biodegradation will be an important fate process in soils. Based on a classification scheme, an estimated Koc value of 8, determined from a log Kow of -0.92 and a regression-derived equation, indicates that this compound is not expected to adsorb to suspended solids and sediment. Volatilization from water surfaces is not expected based upon an estimated Henry's Law constant of 1.3X10-8 atm-cu m/mole, derived from its vapor pressure, 0.13 mmHg, and water solubility, 1X10+6 mg/L. Numerous screening studies using wastewater or sewage inoculum as seed, suggests that this material will be degraded readily under aqueous environments. According to a model of gas/particle partitioning of semi-volatile organic compounds in the atmosphere, Propylene Glycol, which has a vapor pressure of 0.13 mmHg at 25°C, is expected to exist solely as a vapor in the ambient atmosphere. Vapor-phase material is degraded in the atmosphere by reaction with photochemically-produced hydroxyl radicals; the half-life for this reaction in air is estimated to be 32 hours, calculated from its rate constant of 1.2X10-11 cu cm/molecule-sec

BIOACCUMULATION: This product has not been tested for bioconcentration. The following information is available for the components of this product:

CETOSTEARYL ALCOHOL: In a 3-day static exposure study using golden orfe fish (Leuciscus idus melanotus), a bioconcentration factor (BCF) of 56 was observed. According to a classification scheme, this BCF suggests the potential for bioconcentration in aquatic organisms is moderate, provided the compound is not metabolized by the organism. A

24-hr BCF of 17000 was observed in algae (*Chlorella fusca*).

PROPYLENE GLYCOL: An estimated BCF of 3 was calculated, using a log Kow of -0.92 and a regression-derived equation. According to a classification scheme, this BCF suggests the potential for bioconcentration in aquatic organisms is low

ECOTOXICITY: No specific information is currently available on the effect of this product on plants or animals in the environment. This product may be harmful to contaminated terrestrial and aquatic plant and animal life, especially in large quantities.
