ROUTES OF ENTRY: Dermal, Injection, Inhalation, Ingestion

ACUTE EFFECTS OF EXPOSURE: <u>Employee exposure to hazardous components when handled and</u> <u>administered according to the product insert is expected to be minimal</u>. However, sufficient exposure to formaldehyde in large quantities as may be encountered during a large spill or other unforeseeable event, may cause irritation of the upper respiratory tract, eyes and skin. Respiratory tract infection may include burning of the nose throat and coughing. In severe situations pneumonitis, pulmonary edema and even death may occur.

Accidental human injection of inactivated oil emulsion vaccines, those containing adjuvants, diluents and stabilizers may cause serious localized reactions and direct tissue injury. Symptoms of exposure may include significant swelling and pain at the area of injection. Other concerns may involve bacterial infection from needles <u>used</u> in multiple animal vaccinations.
